ORDER SCHEDULING PUBLIC HEARING  
AND REQUESTING PUBLIC COMMENT

On June 5, 2009, Chief Justice James W. Hardesty filed a petition in this matter requesting that this court adopt rules in order to implement the foreclosure mediation program established by Assembly Bill 149. The petition and proposed rules are attached.

The Nevada Supreme Court will conduct two public hearings on the proposed rules. The first hearing will be held on Tuesday, June 16, 2009, at 4:00 p.m. in the Nevada Supreme Court Courtroom, 201 S. The second hearing will be held on Friday, June 26, 2009, at 12:00 p.m. in the Nevada Supreme Court Courtroom, 200 Lewis Avenue, 17<sup>th</sup> Floor (Regional Justice Center), Las Vegas, Nevada. The hearing will be videoconferenced to the Nevada Supreme Court Courtroom in Carson City, Nevada.

Further, this court invites written comment from the bench, bar and public regarding the proposed rules. An original and 8 copies of


